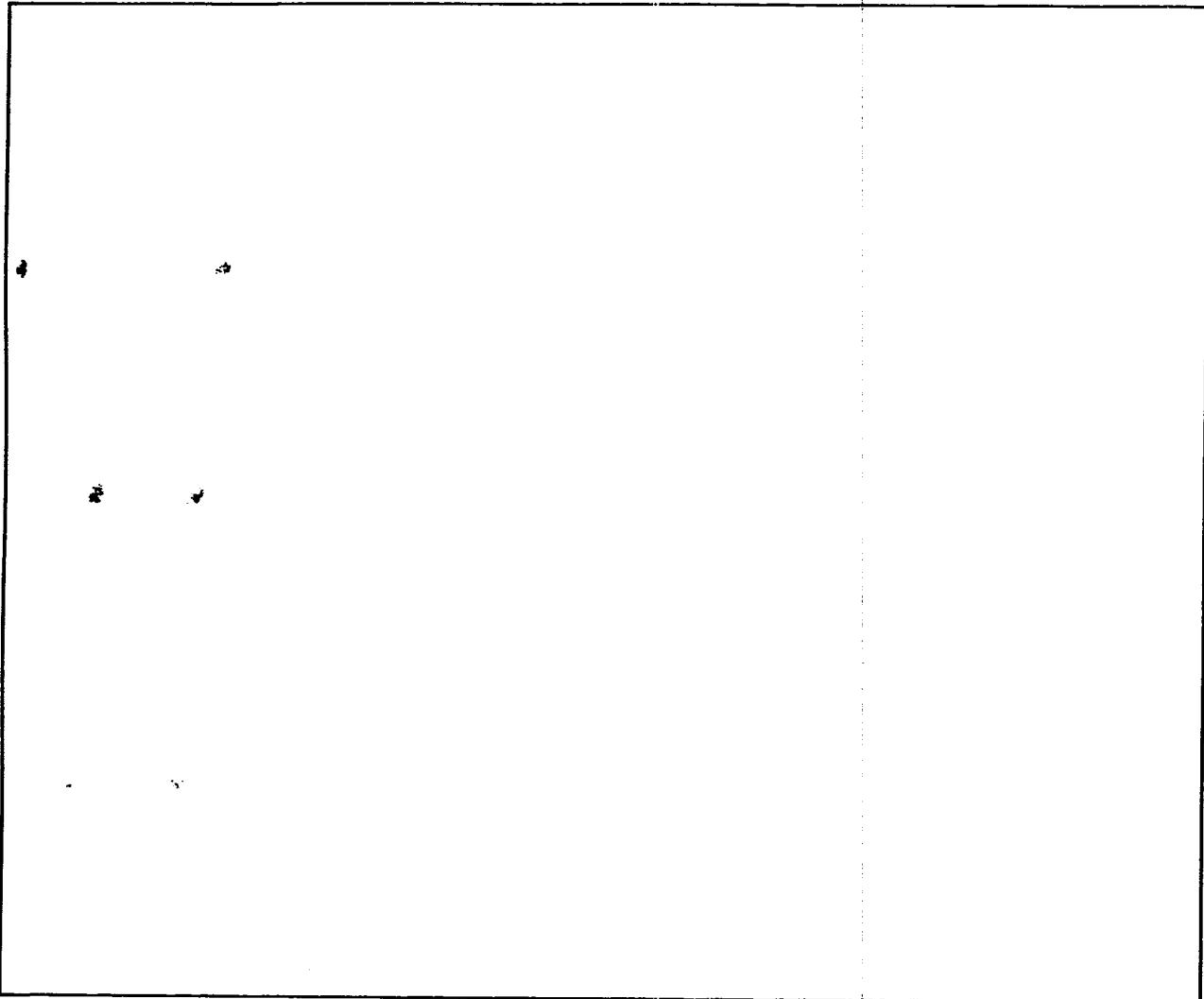

AUTHORIZED USE OF INM HELOS THIS MORNING TO ASSIST WITH EVACUATING BETWEEN 19-20 WOUNDED (INCLUDING 2-3 CIVILIANS AND A CHILD) AND 10 DEAD GC. THE PERUVIAN MILITARY SENT IN THREE HELOS TO SECURE THE AREA AND MRTA FORCES HAD DISENGAGED BEFORE US HELOS ARRIVED. THE GC OBTAINED PERMISSION TO USE THE NEARBY PRIVATE PALMAS AIRSTRIP, AND THE AMBASSADOR HAS AUTHORIZED THE C-123 TO PICK UP THE WOUNDED, WHO WILL BE FERRIED THERE BY HELO FROM THE SANTA LUCIA BASE. DEA MAY SEND A SPECIAL PRESSURIZED PLANE TO FLY THE MOST SERIOUSLY WOUNDED OUT. THE PRIME MINISTER HAS FLOWN TO THE UHV. (HOLSTEIN)
