



2. THE FEDERAL AVIATION ADMINISTRATION (FAA), OFFICE OF CIVIL AVIATION SECURITY, PRODUCES AN "FAA INFORMATION CIRCULAR." THE INFORMATION CIRCULAR PROVIDES U.S. AIR CARRIERS WITH INFORMATION THAT THEY SHOULD BE AWARE OF IN CARRYING OUT THEIR SECURITY DUTIES UNDER APPROPRIATE FEDERAL REGULATIONS (14 CFR 108). THE INFORMATION CIRCULAR CONTAINS NO MANDATORY REQUIREMENTS OR INSTRUCTIONS FOR AIR CARRIERS; EACH CARRIER DECIDES ON ITS OWN HOW TO HANDLE AND DISSEMINATE EACH INFORMATION

CIRCULAR. ANOTHER TYPE OF MESSAGE, WHICH IS CALLED A SECURITY DIRECTIVE, IS USED TO DISSEMINATE INSTRUCTIONS ON MANDATORY SECURITY REQUIREMENTS.

- 3. THE DEPARTMENT TRANSMITS THE TEXT OF FAA INFORMATION CIRCULARS TO APPROPRIATE POSTS. POSTS ARE AUTHORIZED, WHERE THEY BELIEVE IT APPROPRIATE, TO SHARE THE CONTENTS OF FAA INFORMATION CIRCULARS WITH HOST GOVERNMENT OFFICIALS RESPONSIBLE FOR CIVIL AVIATION, SECURITY, AND INTELLIGENCE. WITHIN THE POST, DISSEMINATION OF THE CIRCULAR IS GOVERNED BY INSTRUCTIONS CONTAINED IN REFTEL. INFORMATION CIRCULARS ARE NOT INTENDED FOR EITHER THE BROAD POST COMMUNITY OR THE GENERAL PUBLIC, AND SHOULD NOT BE THE SUBJECT OF INTERNAL POST TRAVEL ADVISORIES, BE POSTED IN PUBLIC PLACES, OR OTHERWISE DISTRIBUTED EXCEPT AMONG OFFICERS RESPONSIBLE FOR AVIATION SECURITY MATTERS. SUCH PUBLIC RELEASE OF THESE CIRCULARS IS PROHIBITED BY THE DIRECTOR OF FAA CIVIL AVIATION SECURITY.

5. FOLLOWING IS TEXT OF INFORMATION CIRCULAR IC-92-09 DATED 7/23/92:

BEGIN TEXT:

INFORMATION: THE PERUVIAN INSURGENT ORGANIZATION SENDERO LUMINOSO (SHINING PATH - SL) HAS ANNOUNCED ANOTHER "ARMED STRIKE" FOR JULY 22-24, 1992. RECENT ACTIVITY IN LIMA, MOST NOTABLY IN THE BUSINESS DISTRICT OF MIRAFLORES, SHOWS THE GROUP HAS BECOME MORE INDISCRIMINATE IN ITS USE OF CAR BOMBS. A LARGE CAR BOMB IN MIRAFLORES ON JULY 16, 1992, LEFT 18 PEOPLE DEAD AND OVER 200 INJURED. MORE RECENTLY, A PRELIMINARY PRESS REPORT INDICATES THAT ON JULY 22 SL FIRED A MORTAR AT A PERUVIAN NAVAL AIR BASE IN CALLAO. THE NAVAL AIR BASE IS ADJACENT TO A PERUVIAN AIR FORCE BASE LOCATED NEXT TO LIMA AIRPORT. THE MORTAR SHELL WAS FIRED FROM 300 METERS AWAY AND HIT AN OFFICER'S DORMITORY. IN VIEW OF THE RECENT VIOLENCE, WHICH HAS INCLUDED ATTACKS ON THE BOLIVIAN EMBASSY, GOVERNMENT



BUILDINGS, POLICY STATIONS, BANKS, A FACTORY AND PUBLIC TRANSIT BUSES, THE U.S. EMBASSY IS URGING AMERICANS TO USE CAUTION WHEN TRAVELLING TO LIMA.


