## 1. CRIMINAL (U)

(C/NF/WN) MOST CRIMINAL ACTIVITY AROUND SANTA LUCIA REVOLVES AROUND THE DRUG TRADE, AND THE CORRUPTION THAT RESULTS FROM IT.

THE PERUVIAN MILITARY'S REFUSAL TO INVESTIGATE ALLEGATIONS OF MISCONDUCT SHOWS THE EXTENT THAT CORRUPTION HAS EMBEDDED ITSELF INTO PERUVIAN SOCIETY.

#### 2. TERRORISM (U)

(Y) (S/WN) SANTA LUCIA HAS BEEN ATTACKED BY SENDERO LUMINOSO INSURGENTS ON SEVERAL OCCASIONS, WITH THE LARGEST ATTACK OCCURRING FROM 14-16 JUNE 1991. UH-1 SUPPORT, SMALL ARMS AND MORTAR FIRE PREVENTED THE BASE PERIMETER FROM BEING BREACHED AND NO FRIENDLY CASUALITIES WERE REPORTED. ADDITIONALLY, SENDERO LUMINOSO INSURGENTS HAVE USED SMALL ARMS FIRE AGAINST SANTA LUCIA UH-1 HELICOPTERS. ON 12 JANUARY 1992 ONE UH-1 WAS POSSIBLY SHOT DOWN WITH SMALL ARMS FIRE (7.62MM) WITH FOUR KILLED

AND ON 20 JUNE ANOTHER UH-1 WAS LOST WITH THREE KILLED

# 5. AIRPORT (U)

(S/NF/WN) THE COUNTERDRUG BASE CAMP AT THE AIRPORT WAS ESTABLISHED IN 1987 AND THE FACILITIES ORIGINALLY CONSTITUTED FIVE TENTS. BASE FACILITIES HAVE GROWN TO INCLUDE MORE TENTS, SOME PERMANENT STRUCTURES, COMMON AREAS, AVIATION INFRASTRUCTURES, BUNKERED PERIMETER POSITIONS WITH PERIODIC MACHINEGUN EMPLACEMENTS, AND COMMUNICATIONS EQUIPMENT. HOT SHOWERS ARE AVAILABLE AND THE FOOD IS REPORTED TO BE VERY GOOD.

CONSTRUCTION IS UNDERWAY ON ONE AIRCRAFT HANGER, SEVEN HELICOPTER REVETMENTS, AND SECURITY TOWERS. AIRFIELD FACILITIES ARE BEING EXPANDED AND UPGRADED TO HANDLE COMMERCIAL AVIATION TRAFFIC AFTER THE AIRFIELD WAS CONVERTED INTO A MUNICIPAL AIRPORT IN OCT 1991.

## 6. TOWN (U)

(FOUO) THE TOWN OF SANTA LUCIA (POP. ABOUT 1,500) IS LOCATED JUST OUTSIDE THE AIRFIELD AREA ON THE BANK OF THE HUALLAGA RIVER, AND IS HEAVILY POPULATED BY PERSONNEL EMPLOYED BY THE PALMAS DE ESPINO OIL COMPANY. MANY OF THE HOMES HAVE TELEVISON ANTENNAS WHICH ARE ABLE TO PICK UP A SINGLE STATION. THE OIL COMPANY'S REFUSAL TO PAY A "WAR TAX" TO THE SENDERO LUMINOSO INSURGENT GROUP LEAD TO THE CREATION OF WHAT IS DESCRIBED AS AN EXCELLENT SECURITY FORCE COMPRISED OF FORMER PERUVIAN SPECIAL FORCES AND POLICE PERSONNEL. TRANSPORTATION ACROSS THE HUALLAGA RIVER IS DEPENDANT ON TWO FERRIES, ONE WHICH IS CAPABLE OF TAKING CARGO TRUCKS OF A SUBSTANIAL SIZE. IN ADDITION TO HOMES,
