SUBJECT: MILITARY COURT HANDS DOWN LIFE TERMS

TO SENDERO MEMBERS

1. FOR THE FIRST TIME IN RECENT PERUVIAN JURISPRUDENCE, MILITARY COURTS IN PERU HAVE SENTENCED TWO ACCUSED MEMBERS OF THE SENDERO LUMINOSO (SL) GUERRILLA GROUP TO LIFE

IMPRISONMENT FOR TREASON. THE SECRET MILITARY TRIALS, WHICH REPORTEDLY LASTED TWO DAYS, WERE HELD AT THE MIGUEL CASTRO CASTRO PRISON. THE SENTENCES WERE HANDED DOWN TUESDAY NIGHT, ACCORDING TO PERUVIAN NEWSPAPERS. DEFENSE LAWYERS HAVE APPEALED TO THE SUPREME COURT OF MILITARY JUSTICE WHICH HAS FIFTEEN DAYS TO UPHOLD OR REVERSE THE CONVICTION.

- 2. THE TRIALS WERE CONDUCTED BY A SPECIAL MILITARY COURT ("CONSEJO DE GUERRA ESPECIAL"). THE IDENTITIES OF THE PRESIDING JUDGES AND THE PROSECUTING ATTORNEYS WERE KEPT SECRET.
- 3. THE TWO SL MEMBERS, JUAN CARLOS QUISPE GUTIERREZ AND EDILBERTO ANTONIO MACALUPU GARCIA-WERE CONVICTED OF THE AUGUST 14, 1992, MURDER OF OF POLICE CAPTAIN CARLOS VERAU ASMAT. ONE DAY EARLIER, AUGUST 13, THE FUJIMORI GOVERNMENT HAD PROMULGATED A DECREE (DECREE LAW 25659) PERMITTING MILITARY COURTS TO TRY AND SENTENCE INDIVIDUALS ACCUSED OF AGGRAVATED ACTS OF TERRORISM. THE TWO TERRORISTS WERE ARRESTED AUGUST 14 AND QUESTIONED BY SECURITY POLICE FOR 15 DAYS BEFORE BEING TURNED OVER TO MILITARY AUTHORITIES FOR TRIAL. THE TOTAL LEGAL PROCESS WAS REPORTEDLY COMPLETED IN TWENTY DAYS.
- 4. IT IS WIDELY ANTICIPATED THAT SE FOUNDER AND LEADER ABIMAEL GUZMAN AND OTHER LEADERS OF THE GUERILLA GROUP CAPTURED IN LIMA SEPTEMBER 12

WILL BE SIMILARLY TRIED IN THE MILITARY COURT SYSTEM. BRAYSHAW
