MORE SPECIFICALLY IS IT NOT TRUE THAT DESPITE THE DECLINE IN THE NUMBER OF REPORTED DISAPPEARANCES BETWEEN AUGUST AND DECEMBER 1991, THERE IS NO INDICATION THAT THE OVERALL LEVEL OF HUMAN RIGHTS VIOLATIONS BY STATE AGENTS HAS DECREASED; INDEED; THERE ARE SIGNS THAT IT HAS

ANSWER: ACCORDING TO THE FEBRUARY 5 FIGURES FROM THE COORDINADORA:

-- DISAPPEARANCES ATTRIBUTED TO THE GOVERNMENT FOR AUGUST-DECEMBER (71) DECREASED BY AN AVERAGE OF 18.5 PER MONTH AS COMPARED TO JANUARY-JULY (229).

-- EXTRAJUDICIAL KILLINGS ATTRIBUTED TO GOVERNMENT FORCES FOR AUGUST-DECEMBER (46) INCREASED BY AN AVERAGE OF 1.6 PER MONTH AS COMPARED TO JANUARY-JULY (53). (HOWEVER, THIS INCLUDED 30 KILLINGS IN SAN MARTIN IN OCTOBER WHICH THE COORDINADORA CANNOT INDEPENDENTLY CONFIRM; NEVERTHELESS, THE COORDINADORA IS RECORDING THEM, CONTRARY TO ITS NORMAL PRACTICE, IN LIGHT OF PRESS REPORTS WHICH HAVE NOT BEEN DISPROVEN. ALSO THE COORDINADORA'S FIGURES SHOW NO/NO KILLINGS ATTRIBUTED TO THE GOP IN EITHER

-- TOTAL DISAPPEARANCES AND EXTRAJUDICIAL KILLINGS ATTRIBUTED TO GOVERNMENT FORCES IN JANUARY-JULY DROPPED FROM 282 (AVERAGE PER MONTH - 40.3) TO 117 FOR AUGUST-DECEMBER (AVERAGE PER MONTH - 23.4). APPARENT POLITICAL MOTIVATION, THERE WERE 30 SUCH DEATHS BETWEEN THE ZUNIGA BOMBING (CARRIED HERE AS A DEATH FOR THAT WAS THE CLEAR INTENT) IN MARCH 1990 AND THE DEATHS OF THE 3 RODRIGUEZ FAMILY MEMBERS IN HUACHO IN FEBRUARY 1992. SETTING ASIDE THE 17 BARRIOS ALTOS KILLINGS -- AS A STATISTICAL ANOMALY, ALTHOUGH CLEARLY POLITICAL IN NATURE -- THERE WERE 10 POLITICAL DEATH SQUAD MURDERS FROM JANUARY UP TO THE BARRIOS ALTOS CASE IN OCTOBER -- AN AVERAGE OF 1 A MONTH. FOLLOWING BARRIOS ALTOS THERE HAVE BEEN 3 "POLITICAL" DEATH SQUAD KILLINGS OVER 3 MONTHS, AN AVERAGE OF 1 A MONTH THROUGH FEBRUARY 18.

CONCLUSION: FROM THE START OF 1990 TO THE PRESENT THERE HAS BEEN AN UNDERLYING POLITICAL ASSASSINATION RATE BY DEATH SQUAD ACTIVITY OF 1 A MONTH WHICH HAS BEEN CONSISTENT LEADING UP TO AND FOLLOWING THE NOVEMBER 3 ATROCITY AT BARRIOS ALTOS. THAT UNDERLYING RATE OF POLITICAL DEATH SQUAD ACTIVITY DOES NOT SEEM TO HAVE CHANGED.

-- BY CONTRAST, STARTING IN DECEMBER OF 1991, WE PICKED UP DEATH SQUAD INCIDENTS WHICH APPEAR FUNDAMENTALLY NON-POLITICAL IN NATURE. A TOTAL OF 10 PEOPLE WERE KILLED AND 3 WOUNDED IN THREE SEPARATE CASES, 2 IN DECEMBER 1 IN JANUARY. THESE WERE ALL HUMAN RIGHTS VIOLATIONS, HAVE NO DOUBT ABOUT IT. HOWEVER, THIS APPEARS TO BE A NEW TYPE OF DEATH SQUAD ACTIVITY, NOT PREVIOUSLY

IDENTIFIED BY HUMAN RIGHTS MONITORING ORGANIZATIONS IN PERU. IN THE HUACHIPA CASE, THE POLICE THEMSELVES HAVE ARRESTED AND CHARGED 5 POLICEMEN WITH MURDER IN WHAT APPEARS TO BE A MAFIA STYLE RUB-OUT OF GANGS INTERFERING WITH POLICE PROTECTION RACKETS. THE RAMIRO PRIALE HIGHWAY AND COMAS CASES ARE A BIT LESS CLEAR, BUT GENERALLY ARE THOUGHT TO BE IN THE SAME CATEGORY, I.E., PROBABLY POLICE KILLINGS OF COMMON CRIMINAL ELEMENTS.

18, OR AN AVERAGE OF 4 A MONTH. THE
JANUARY-JULY DEATH SQUAD KILLINGS/ATTEMPTS
TOTALED 6 OR JUST UNDER 1 A MONTH. THEREFORE,
INCLUDING BARRIOS ALTOS, THE POLITICAL DEATH
SQUAD ACTIVITY STARTING IN AUGUST INCREASED BY
SOME 19 DEATHS MORE THAN WOULD HAVE BEEN
PROJECTED FROM THE JANUARY-JULY PERIOD. BY
CONTRASTING THE JANUARY-JULY AND AUGUST-DECEMBER

-- EVEN COMBINING THE TOTAL INCREASE IN EXTRAJUDICIAL EXECUTIONS AND ALL DEATH SQUAD KILLINGS AND COMPARING THE RESULTS WITH THE DECREASE IN DISAPPEARANCES, THE ADDITIONAL DEATHS DO NOT OFFSET REDUCED DISAPPEARANCES. TO BE SPECIFIC, 53 EXTRAJUDICIAL EXECUTIONS REPORTED BETWEEN JANUARY AND JULY AVERAGED 7.6 PER MONTH. MOREOVER, 46 EXTRAJUDICIAL EXECUTIONS IN THE AUGUST-DECEMBER PERIOD AVERAGED 9.2 PER MONTH. THIS REPRESENTS AN INCREASE OF 1.6 EXTRAJUDICIAL EXECUTIONS PER MONTH OVER THE JANUARY-JULY PERIOD. THE PROJECTED AUGUST-FEBRUARY EXTRAJUDICIAL EXECUTIONS BASED ON JANUARY-JULY DATA WOULD HAVE BEEN 38. THIS IS 8 LESS THAN REALLY OCCURED THROUGH THE END OF DECEMBER, SUBSEQUENT TO WHICH WE HAVE NO ACTUAL DATA. HOWEVER, PROJECTING THE AUGUST-DECEMBER 1.6 PER MONTH INCREASE THROUGH MID-FEBRUARY, AN ADDITIONAL 2 KILLINGS MIGHT BE ANTICIPATED. THIS GIVES A TOTAL COMPOSIT INCREASE IN "ACTUAL" (THROUGH DECEMBER EQUALS 8) PLUS "PROJECTED" (JANUARY-MID-FEBRUARY 1992 EQUALS 2) EXTRAJUDICIAL KILLINGS OF 10 MORE THAN PROJECTIONS FROM THE JANUARY THROUGH JULY 1991

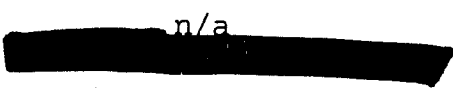
