2. SUMMARY: PRIME MINISTER OSCAR DE LA PUENTE IS CONFIDENT THAT THE NOVEMBER 22 CONSTITUENT CONGRESS ELECTIONS WILL COME OFF SMOOTHLY. HE PREDICTS THAT THE GOVERNMENT WILL NOT WIN A STRONG MAJORITY, BUT WILL BE IN A POSITION TO LEAD EFFECTIVELY IN THE CCD. HE WELCOMES OUTSIDE OBSERVERS AND SEES ELECTIONS AS OPPORTUNITY TO RESTORE PERU'S INTERNATIONAL SUPPORT. HE EXPRESSED SURPRISE THAT COUNTRIES THAT PUT SUCH STRONG PRESSURE ON GOP TO HOLD ELECTIONS MADE THEMSELVES SCARCE WHEN THEY HAD OPPORTUNITY TO GIVE MATERIAL SUPPORT TO PROCESS.

PROGRESS SO FAR IN HOLDING THE ELECTIONS. THERE ARE GREAT LOGISTICAL CHALLENGES, PARTICULARLY IN GETTING VOTING MATERIALS TO POLLING PLACES THROUGHOUT THE COUNTRY, BUT GOP IS CONFIDENT THAT IT WILL GET THIS DONE ON TIME. IT WILL USE ALL TRANSPORTATION RESOURCES IT HAS TO DO THE JOB, INCLUDING MILITARY HELICOPTERS. THE MILITARY, HE PROMISED, WILL ACT WITH PERFECT IMPARTIALITY.

12. CHARGE RAISED DIRECTLY WITH DE LA PUENTE HUMAN RIGHTS TALKING POINTS THAT HAD BEEN PREVIOUSLY DELIVERED TO GOP (STATE 344863). HE BEGAN BY SAYING THAT THE USG IS PLEASED THAT THE GOP HAD REGISTERED IMPORTANT VICTORIES AGAINST THE TERRORIST ORGANIZATIONS THAT HAVE SIGNIFICANTLY UNDERMINED THEIR CAPABILITIES TO VIOLATE THE RIGHTS OF PERUVIAN CITIZENS. THE SAN JOSE HUMAN RIGHTS ACCORD, DE LA PUENTE SAID THAT GOP HAD DECIDED TO PUT THIS OFF. ITS PRINCIPAL AIM WAS TO REESTABLISH THE DEATH PENALTY FOR USE IN TERRORISM CASES. CONSIDERING THE INTERNATIONAL REACTION AND THE JURIDICAL COMPLICATIONS IN RENOUNCING THE TREATY, THE GOP WILL SEEK OTHER MEANS TO DEAL WITH ITS GOALS VIS-A-VIS THE DEATH PENALTY. THE QUESTION WILL BE LEFT WITH THE CCD. HE NOTED THAT A NUMBER OF LATIN STATES SUBSCRIBE TO THE SAN JOSE ACCORD AND HAVE THE DEATH PENALTY AS WELL, INDICATING THE GOP WOULD EXPLORE JURIDICAL BASIS USED BY THOSE STATES. 15. CHARGE SAID WE HAVE INFORMAL INDICATIONS THAT A SIGNIFICANT U.S. DELEGATION COULD COME TO PERU FOR THE NOVEMBER 22 ELECTIONS. MFA OFFICERS HAD SIMILAR INDICATIONS FROM THEIR EMBASSY IN WASHINGTON. CHARGE SAID THIS IS AN EXCELLENT OPPORTUNITY FOR PERU TO GET ITS STORY ACROSS TO KEY FIGURES IN THE WASHINGTON POLITICAL COMMUNITY.
