 - O WHILE WE ARE HEARTENED BY GOP ASSURANCES THAT CARLOS CHIPOCO WILL BE ABLE TO TRAVEL FREELY IN PERU ONCE HE RETURNS, THE GOP SHOULD GUARANTEE THAT MR. CHIPOCO WILL NOT BE ARRESTED OR OTHERWISE PERSECUTED UPON HIS RETURN.
 - O THE ATTORNEY GENERAL AND PRIME/FOREIGN MINISTER SHOULD OFFICIALLY INFORM MR. CHIPOCO THAT HIS NAME WAS ERRONEOUSLY INCLUDED IN A LIST OF ALLEGED TERRORISTS. HE SHOULD ALSO BE OFFICIALLY INFORMED THAT HE WILL NOT BE ARRESTED OR PROSECUTED UPON HIS RETURN TO PERU.
 - O WE HAVE BEEN TOLD THAT THE FORTY-THIRD DISTRICT PROSECUTOR, WHO INVESTIGATES SHINING PATH ACTIVITIES ABROAD, HAS DETERMINED THAT THERE ARE NO GROUNDS ON WHICH TO PROSECUTE THREE OTHER PEOPLE -- FIDEL DOLORIAR, EDWIN REANO. AND MIRIAM CHIANG, ALL MEMBERS OF GRUPO PERU -- AND WILL NOT PURSUE THESE


-- THERE HAS BEEN VERY LITTLE PROGRESS TO DATE IN RESOLVING HIGH-PROFILE HUMAN RIGHTS CASES. INCLUDING THOSE CITED IN 1991 BY THE U.S. CONGRESS AS CONDITIONS TO DISBURSEMENT OF U.S. ASSISTANCE TO PERU.

-- IDENTIFICATION AND DISCIPLINE OF PERSONS RESPONSIBLE FOR ABUSES WOULD DEMONSTRATE UNEQUIVOCALLY -- BOTH WITHIN AND OUTSIDE PERU -- THAT SELECTIVE KILLINGS AND DISAPPEARANCES WILL NOT BE TOLERATED.

O MANY CREDIBLE OBSERVERS SUSPECT THAT ARMY INTELLIGENCE AGENTS MAY HAVE BEEN RESPONSIBLE FOR THE NOTORIOUS BARRIOS ALTOS MASSACRE OF NOVEMBER 1991, YET THE INVESTIGATION OF THIS INCIDENT HAS STALLED. THAT INVESTIGATION SHOULD BE REINVIGORATED.

O SIMILARLY, WE URGE THE GOVERNMENT OF PERU TO OPEN AN INVESTIGATION INTO THE AUGUST - OCTOBER 1992 ASSASSINATIONS AND DISAPPEARANCES IN HUANCAYO AND FOLLOW WITH A PUBLIC ANNOUNCEMENT.

O WE ALSO URGE THAT THE NATIONAL EDUCATION UNIVERSITY (LA CANTUTA) DISAPPEARANCES. WHICH OCCURRED IN LIMA AT ABOUT THE SAME TIME, BE







O WE HOPE THAT THE CURRENT CONGRESSIONAL HUMAN RIGHTS COMMITTEE, PRESIDED OVER BY ROGER CACERES. WILL CARRY SIMILAR WEIGHT. PUBLIC ENCOURAGEMENT BY THE PRESIDENT OF CONGRESSIONAL OVERSIGHT ON HUMAN RIGHTS ISSUES WOULD SEND A STRONG SIGNAL THAT PERU IS COMMITTED TO DEVELOPING A STRONG DEMOCRACY WITH CHECKS AND BALANCES.

-- AT THE APRIL, 1992, OAS AD HOC MEETING OF FOREIGN MINISTERS IN NASSAU, THE GOVERNMENT OF PERU INVITED THE INTER-AMERICAN COMMISSION ON HUMAN RIGHTS TO VISIT PERU. THE SUPPORTING RESOLUTION URGES THE GOP TO FORMALIZE THE INVITATION. SINCE THAT TIME, THE GOP HAS TWICE POSTPONED VISITS FROM THE IACHR BECAUSE THEY CONFLICTED, FIRST WITH THE NOVEMBER, AND LATER WITH THE JANUARY. ELECTIONS.


O THE GOVERNMENT OF PERU SHOULD SET A FIRM DATE WITH THE IACHR FOR A VISIT TO PERU.

-- WE ALSO STRONGLY URGE THE GOP TO TAKE ADVANTAGE OF THE ON-GOING FORTY-NINTH SESSION OF THE UN COMMISSION ON HUMAN RIGHTS TO REQUEST THE ADVISORY SERVICES PROVIDED BY THE HUMAN RIGHTS CENTER. THIS COULD PREVENT MORE ONEROUS

WHILE THE USG RECOGNIZES THE NEED FOR SPECIAL COURTS TO TRY ACCUSED TERRORISTS, WE ARE DEEPLY CONCERNED WITH REPORTS THAT TERRORISTS MAY BE RECEIVING SUMMARY TRIALS, OFFERING LITTLE OPPORTUNITIES FOR DEFENSE.
