1. SUMMARY: ANOTHER ANONYMOUS NOTE, WHOSE
AUTHORS PURPORT TO BE MILITARY OFFICERS
INTERESTED IN JUSTICE AND HUMAN RIGHTS, IS
MAKING THE ROUNDS IN LIMA, THIS TIME ACCUSING
BRIG. GEN. CARLOS TORRES RODRIGUEZ OF
MASTERMINDING THE ABDUCTIONS, TORTURE AND
EXECUTIONS OF 31 UNIVERSITY STUDENTS IN HUANCAYO

IN 1992. AS WITH THE FIRST DOCUMENT WRITTEN BY "SLEEPING LION," WHICH IMPLICATED THE ARMY IN THE "LA CANTUTA" DISAPPEARANCES, THIS ONE CONTAINS SUFFICIENT DETAIL TO WARRANT A CLOSER LOOK INTO THE ACCUSATIONS BY GOP AUTHORITIES. END SUMMARY.

2. [REDACTED] "SLEEPING LION" ("LEON DORMIDO") HAS STRUCK AGAIN. IN A DOCUMENT PASSED TO US APRIL 20, PRESUMABLY THE SAME AUTHORS OF THE NOTE THAT IMPLICATED SEVERAL HIGH-RANKING ARMY OFFICERS IN THE "LA CANTUTA" UNIVERSITY DISAPPEARANCES (REFTEL A) HAVE ACCUSED SPECIFIC OFFICERS OF ORDERING AND/OR CONDONING THE SYSTEMATIC ABDUCTIONS AND EXECUTIONS OF 31 STUDENTS OF HUANCAYO'S UNIVERSIDAD DEL CENTRO IN 1992. THE LATEST NOTE POINTS TO BRIGADIER GENERAL CARLOS TORRES RODRIGUEZ AS THE INTELLECTUAL AUTHOR OF THE HUANCAYO DISAPPEARANCES.

ADDRESSED TO "CCD, THE MEDIA, CHURCH, HUMAN RIGHTS GROUPS AND MEMBERS OF THE ARMED FORCES," GEN. TORRES WAS NAMED POLITICO-MILITARY CHIEF OF THE MANTARO FRONT IN 1992, REPLACING HIS "MENTOR," GEN. LUIS PEREZ DOCUMET, WHO WAS IMPLICATED IN THE LA CANTUTA ABDUCTIONS BY THE FIRST "SLEEPING LION" NOTE.

4. [REDACTED] THE NOTE GOES ON TO CLAIM THAT IN MARCH 1992, A SOCIOLOGY STUDENT AT THE UNIVERSIDAD DEL CENTRO, MIDA LILA GOZAR ORTEGA, WAS DETAINED BY ARMY INTELLIGENCE. UNDER TORTURE, THE DOCUMENT ALLEGES, SHE WAS FORCED TO NAME OVER THIRTY UNIVERSITY STUDENTS WHO WERE ALLEGEDLY MEMBERS OF SENDERO LUMINOSO (SL). AFTER THE INTERROGATION ENDED, ACCORDING TO THE REPORT, GOZAR WAS EXECUTED AND HER BODY DUMPED IN JAUJA VALLEY.

CAMPANA AND ONCE AS COL. CAMPANA GONZALES, "ORGANIZED SEVERAL KIDNAPPING AND EXECUTION SQUADS" WHO, OVER THE COURSE OF SEVERAL WEEKS, SYSTEMATICALLY ABDUCTED, TORTURED AND MURDERED THE STUDENTS THAT GOZAR HAD NAMED. THE BODIES WERE THEN ALLEGEDLY DUMPED IN THE VALLEY BETWEEN JAUJA AND HUANCAYO AND MADE TO APPEAR AS THOUGH THEIR DEATHS HAD BEEN THE WORK OF SL. THE DOCUMENT CHARGES THAT THE EXECUTIONS WERE AUTHORIZED BY GEN. TORRES.

[REDACTED] THE REPORT ALSO SAYS THAT THE LOCAL DISTRICT ATTORNEY FOR HUMAN RIGHTS, IMELDA TUMIALAN, WHOM IT SAYS WAS "CLOSE" TO TORRES, "RECOMMENDED" THAT THE EXECUTIONS STOP SINCE SHE HAD RECEIVED NUMEROUS COMPLAINTS FROM FAMILY MEMBERS OF THE VICTIMS AGAINST THE ARMED FORCES. BASED ON THAT RECOMMENDATION, TORRES ALLEGEDLY ORDERED GONZALES CAMPANA TO DISPOSE OF THE BODIES IN A DIFFERENT WAY. THE LAST EIGHT BODIES, THE NOTE SAYS, WERE THROWN OUT OF A HELICOPTER OVER THE JUNGLE AREA BETWEEN SAN RAMON AND LA MERCED.

8. [REDACTED] COMMENT: THE LATEST DOCUMENT, THOUGH IT
 PURPORTS TO BE DIRECTED TO THE MEDIA, HAS NOT
 RECEIVED MEDIA ATTENTION YET. AGAIN, WE CANNOT
 COMMENT ON THE AUTHENTICITY OF THE ALLEGATIONS
 BECAUSE WE DO NOT KNOW WHO WROTE THE REPORT.
 BASED ON AN OCTOBER 1992 VISIT TO HUANCAYO (REF
 B), WE CONCLUDED IT WAS ALMOST CERTAIN THAT THE
 ARMY HAD SELECTED AND EXECUTED THE STUDENTS AS
 SUSPECTED SL MEMBERS. AS MENTIONED IN REFTTEL,
 RUMOR HAS IT THAT THE AUTHORS MIGHT BE THE
 IMPRISONED NOVEMBER 13 COUP PLOTTERS. IF SO,
 THEY COULD BE TRYING TO MOUNT A SMEAR CAMPAIGN
 AGAINST THE ARMY LEADERSHIP; HOWEVER, IF THE
 ARMY IS RESPONSIBLE FOR THE DISAPPEARANCES, THE
 COUP PLOTTERS WERE IN A POSITION TO KNOW ABOUT
