SUMMARY: ANOTHER ANONYMOUS DOCUMENT UNDER THE "SLEEPING LION" PSEUDONYM, WHOSE AUTHORS CLAIM TO BE MILITARY OFFICERS INTERESTED IN JUSTICE AND THE ARMY'S IMAGE, PURPORTS TO RECOUNT THE DETAILS OF THE TORTURE AND EXECUTION OF SOME 31 UNIVERSITY STUDENTS IN HUANCAYO IN 1992. THE DOCUMENT ALLEGES THAT EVEN THE DISTRICT ATTORNEY FOR HUMAN RIGHTS IN HUANCAYO

IS INVOLVED IN THE COVER-UP, AND CLAIMS THAT IT WILL SOON OFFER A DETAILED REPORT ON ALL DISAPPEARANCES IN THE MANTARO FRONT IN 1991. END SUMMARY.

2. [REDACTED] THE APPROXIMATELY 31 STUDENTS OF THE UNIVERSIDAD DEL CENTRO WHO DISAPPEARED BETWEEN JULY AND OCTOBER 1992 IN HUANCAYO WERE TORTURED BY ARMY OPERATIVES BEFORE BEING EXECUTED, ACCORDING TO AN ANONYMOUS DOCUMENT THAT HAS SURFACED IN LIMA. "SLEEPING LION," THE PSEUDONYM FOR A SELF-DESCRIBED GROUP OF DISSATISFIED PERUVIAN MILITARY OFFICERS, HAS RELEASED "PART II" OF WHAT IT PURPORTS TO BE THE TRUTH BEHIND THE ABDUCTIONS OF THE UNIVERSITY STUDENTS (PART I WAS TRANSMITTED REFTEL A). EMBASSY BECAME AWARE OF THE DOCUMENT'S EXISTENCE DURING A JUNE 10 LUNCHEON HOSTED BY CHARGE. POLOFF WAS LATER ABLE TO OBTAIN A COPY FROM A CIVILIAN CONTACT WHO HAS TIES TO THE MILITARY.

3. (U) THIS LATEST REPORT ALLEGES THAT A LTC GONZALEZ CAMPANA (NO FIRST NAME GIVEN), THE LEADER OF THE ARMY DEATH SQUAD ACCORDING TO THE PREVIOUS SLEEPING LION DOCUMENT, SPLIT UP THE KIDNAPPED STUDENTS AND ORDERED THEM TAKEN TO FOUR DIFFERENT ARMY BASES IN THE HUANCAYO AREA: CONCEPCION, ZAPALLANCA, CHUPACA AND CHONGOS BAJO. AT EACH BASE THE DETAINEES WERE PUT IN DEEP PITS IN THE GROUND WITH NO CLOTHES, FOOD OR WATER. THE STUDENTS WERE TAKEN OUT AT DAWN TO AN ISOLATED AREA IN THE COUNTRYSIDE, AND, ACCORDING TO THE DOCUMENT, EXECUTED ONCE THEY ANSWERED INTERROGATORS. THEY WERE SUBJECTED TO CONTINUED PHYSICAL MISTREATMENT IF THEY REFUSED TO TALK, THE REPORT GOES ON.

4. (U) WHEN THE LOCAL DISTRICT ATTORNEY FOR HUMAN RIGHTS, IMELDA TUMIALAN, COMPLAINED ABOUT THE ABDUCTIONS AND BODIES TURNING UP ON ROADSIDES, THE FIRST DOCUMENT ALLEGED, MANTARO FRONT COMMANDER GEN. CARLOS TORRES ORDERED

GONZALES CAMPANA TO DISPOSE OF THE CORPSES BY THROWING THEM OUT OF HELICOPTERS INTO THE JUNGLE. THE NEW DOCUMENT CLAIMS THAT THE HELICOPTER FLIGHTS WERE RECORDED IN THE AIR FORCE'S FLIGHT LOG AND WERE CARRIED OUT BY A PILOT NAMED EDUARDO RIOS VILLARAN, ALIAS "GUSANO" ("WORM").

5. (U) "SLEEPING LION" GOES ON TO CALL FOR AN IN-DEPTH INVESTIGATION INTO THE ABDUCTIONS AND SLAYINGS THROUGH INTERVIEWS WITH THE VICTIMS'

PAGE 04 LIMA 06868 01 OF 02 181816Z FAMILIES. "THE DISTRICT ATTORNEYS SHOULD NOT BE TRUSTED," THE DOCUMENT STATES, "SINCE THEY BLINDLY OBEY ONLY THE ONE WHO APPOINTS THEM, NAMELY (PRESIDENTIAL INTELLIGENCE ADVISER) VLADIMIRO MONTESINOS." IT GOES ON TO ACCUSED TUMIALAN OF KNOWING "THE WHOLE TRUTH."

6. (U) THE DOCUMENT CLOSES BY STATING THAT "SLEEPING LION IS PREPARING A DETAILED REPORT ON ALL THOSE WHO DISAPPEARED IN 1991 DURING THE COMMAND (OF THE MANTARO FRONT) OF THE MURDEROUS GENERAL LUIS PEREZ DOCUMET." IT ADDS THAT GONZALES CAMPANA IS THE ONE WHO KNOWS "EVERY DETAIL OF THE 1991 EXECUTED/DISAPPEARED. JUSTICE

INVESTIGATION. TUMIALAN'S BOSS, THE ASSISTANT  
ATTORNEY GENERAL FOR HUMAN RIGHTS, HAS ALWAYS  
DEFENDED HER IN PRIVATE CONVERSATIONS WITH  
POLOFFS. WE HAVE HEARD, HOWEVER, THAT HUMAN  
RIGHTS GROUPS DO NOT HAVE A HIGH OPINION OF HER.

8. THE AUTHOR(S) OF THE "SLEEPING LION"  
DOCUMENTS OBVIOUSLY HAVE A VENDETTA AGAINST  
PEREZ DOCUMET. SINCE PEREZ DOCUMET PLAYED A  
PROMINENT ROLE IN THE CAPTURE (AND REPORTEDLY  
PERMITTED THE ABUSE) OF THE PARTICIPANTS IN THE  
FAILED NOVEMBER 1992 COUP PLOT, THE JAILED  
CONSPIRATORS MAY BE BEHIND THE RELEASE OF THESE  
DAMAGING PAPERS. AS WE HAVE NOTED PREVIOUSLY,  
IF THE ALLEGATIONS ARE TRUE, THE COUP PLOTTERS  
WOULD HAVE BEEN IN A POSITION TO KNOW HOW THE  
HUANCAYO KILLINGS WERE CARRIED OUT.
