ACCORDING TO THE FOREIGN MINISTRY, EXTRADITION REQUESTS ARE IN TRAIN FOR SL SYMPATHIZERS IN NINE WEST EUROPEAN COUNTRIES, CANADA, THE US AND BOLIVIA. UNFORTUNATELY, THE LIST OF SL ENVOYS APPARENTLY INCLUDES PEOPLE WHO DO NOT BELONG TO SL AND WHO INDEED OPPOSE SL.

18. (U) WITH THE COUP D'ETAT OF APRIL 5 AND THE END OF 12 YEARS OF DEMOCRATIC GOVERNMENT IN PERU, PRESIDENT FUJIMORI BEGAN TO OVERHAUL THE JUDICIAL SYSTEM.
