

7. (SBU) HUMAN RIGHTS OMBUDSMAN JORGE SANTISTEVAN SAID DURING A RADIO INTERVIEW THAT MONTESINOS SHOULD CEASE HIS PUBLIC DUTIES UNTIL AN INVESTIGATION WAS COMPLETED OF HIS ROLE IN THE BRIBERY SCANDAL.
