CHURCH HR GROUP CALLS FOR U.S. HELP

2. THE HEAD OF THE CATHOLIC HUMAN RIGHTS ORGANIZATION (CEAS) AND BISHOP OF PUCALLPA, MSGR. JUAN LUIS MARTIN, REQUESTED USG ASSISTANCE IN PRESSURING THE GOP TO ALLOW A FULL AND IMPARTIAL INVESTIGATION INTO POSSIBLE HUMAN RIGHTS VIOLATIONS IN CONNECTION WITH THE ARMY COUNTERSUBVERSIVE OFFENSIVE IN HUANUCO (REFTELS). MARTIN ASKED APRIL 21 THAT A U.S. DELEGATION TRAVEL TO THE AREA, SPECIFICALLY SUGGESTING THAT THE DUTCH AND ITALIAN EMBASSIES BE INCLUDED TO GIVE THE DELEGATION A MULTILATERAL LOOK. CEAS FELT THE GOP WAS SUCCESSFULLY KEEPING THE CHURCH, THE MEDIA AND HUMAN RIGHTS ORGANIZATIONS IN THE DARK AND THAT THE "OFFICIAL LINE" WAS PREDOMINATING THE ISSUE.
