THE INTERNATIONAL COMMITTEE OF THE RED CROSS
(ICRC). IN HUANUCO CITY, HE DECLARED, ICRC VANS
COULD BE SPOTTED AROUND TOWN GOING ABOUT THEIR
BUSINESS. COMMENT: ICRC ACCESS HAS NOT BEEN
DENIED IN HUANUCO CITY, BUT IN THE NORTHERN PART
OF THE DEPARTMENT AS DESCRIBED ABOVE.

10. COMMENT: THE MILITARY'S DECISION TO
EXCLUDE THE ICRC FROM THE WEST BANK ZONE DAMAGES
ITS CREDIBILITY. THE ARMED FORCES AND GOP LOSE
NOTHING BY GRANTING ACCESS TO THE ICRC, SINCE
THE ORGANIZATION WILL NOT PUBLICLY DENOUNCE ANY
FINDING OF VIOLATION OF INTERNATIONAL
HUMANITARIAN LAW. THEY HAVE EVERYTHING TO GAIN
IN TERMS OF PUBLIC RELATIONS BY ALLOWING THE ICRC
INTO THE ZONE, SINCE DENIAL OF ACCESS WILL RESULT
IN DOMESTIC AND INTERNATIONAL CONDEMNATION.
CHARGE HAS SOUGHT MEETING WITH DEFENSE MINISTER
GEN. VICTOR MALCA TO SEEK INFORMATION ON THE
HUANUCO OPERATIONS. IF MEETING IS GRANTED.
CHARGE WILL URGE THAT GOP GRANT ICRC ACCESS.
