SUPPORT FOR THE ICRC WAS NOT NEW TO THE U.S.- PERU AGENDA. IT WAS USG PRESSURE THAT PERSUADED THE GOP TO INCREASE ICRC ACCESS TO INCLUDE MILITARY FACILITIES, NOT JUST POLICE; AND ICRC ACCESS WERE EXPLICIT CONDITIONS FOR 1991 ESF AND THE 1993 USG DECISION TO JOIN A SUPPORT GROUP FOR PERU. THE FOREIGN MINISTRY WAS OUT OF THE LOOP; THE PRESIDENCY AND THE ARMY WERE UNRESPONSIVE. ONLY THE FACT THAT THE ACCESS PROBLEM WAS PUBLIC AND HARMING PERU'S IMAGE OVERSEAS MOVED THE GOP TO RECONSIDER. USG MOVES TO BRING EUROPEAN UNION INTO PLAY -- VIA A LOW KEY RAISING OF THE ISSUE WITH MFA -- AND OTHER EFFORTS BROUGHT THIS ABOUT. GOP, OF COURSE, DOES NOT WELCOME THIS FOCUS ON PROBLEM AREAS AND WILL CONTINUE TO DODGE AND CREATE DIVERSIONS. OUR FOCUS SHOULD BE ON ICRC ACCESS AND OTHER PROPER INVESTIGATION OF THE HUANUCO KILLINGS, NOT THE GOP DIVERSIONARY TACTICS.
