2. [REDACTED] THE ICRC ON DEC 19 HAS ATTEMPTED TO MEDIATE BETWEEN THE GOP AND MRTA, THUS FAR WITHOUT MAKING ANY PROGRESS. THE GOP CONTINUES TO REJECT MRTA DEMANDS THAT ALL MRTA PRISONERS BE RELEASED. (TASK FORCE-LIMA TELCON)

3. [REDACTED] THERE ARE REPORTS OF AT LEAST ONE CALL BETWEEN PRESIDENT FUJIMORI AND CAPTIVE FOREIGN MINISTER TUDELA. TUDELA REPORTEDLY TOLD FUJIMORI THAT THE MRTA IS SEEKING THE REPEAL OF A CONTROVERSIAL 1995 LAW WHICH AMNESTIED GOP OFFICIALS WHO MIGHT HAVE BEEN INVOLVED IN HUMAN RIGHTS VIOLATIONS.
