





- THE ICRC ON DEC 19 HAS ATTEMPTED TO MEDIATE BETWEEN THE GOP AND MRTA, THUS FAR WITHOUT MAKING ANY THE GOP CONTINUES TO REJECT MRTA DEMANDS THAT PROGRESS. ALL MRTA PRISONERS BE RELEASED. (TASK FORCE-LIMA TELCON)
- THERE ARE REPORTS OF AT LEAST ONE CALL BETWEEN PRESIDENT FUJIMORI AND CAPTIVE FOREIGN MINISTER TUDELA.
