2. [REDACTED] SUMMARY: GOP EFFORTS TO ENGAGE THE TUPAC AMARU REVOLUTIONARY MOVEMENT (MRTA) IN A DIALOGUE VIA A GUARANTOR COMMISSION HAVE NOT YET BEEN SUCCESSFUL BUT CONTINUE. IN ADDITION TO HAGGLING OVER THE COMPOSITION OF THE COMMISSION, THE TUPAC AMARU REVOLUTIONARY MOVEMENT (MRTA) HOSTAGE TAKERS STILL CLING TO THEIR UNREALISTIC DEMAND THAT IMPRISONED MRTA MEMBERS BE RELEASED IN EXCHANGE FOR HOSTAGES. A GOP PRESS NOTE RECEIVED LATE ON JANUARY 17 SETS CONDITIONS FOR THE GUARANTOR COMMISSION'S SESSIONS (TO BE REPORTED SEPTEL) AND STATES UNEQUIVOCALLY THAT THE RELEASE OF IMPRISONED MRTA MILITANTS WILL NOT BE DISCUSSED UNTIL ALL OF THE HOSTAGES HAVE BEEN FREED IN GOOD CONDITION AND THE CAPTORS HAVE DEPARTED. END SUMMARY.

3. (U) MRTA COMANDANTE NESTOR CERPA CARTOLINI INFORMED THE GOP THROUGH THE ICRC ON JANUARY 15 THAT MRTA AGREES TO THE FORMATION OF GUARANTOR COMMISSION TO START SUBSTANTIVE NEGOTIATIONS. CERPA SPECIFICALLY CONCURRED WITH THE DESIGNATION OF ARCHBISHOP JUAN LUIS CIPRIANI AS THE HOLY SEE'S REPRESENTATIVE, AS WELL AS THE PRESENCE OF AN ICRC REPRESENTATIVE. CERPA, HOWEVER, TOLD THE GOP THAT HE BELIEVED ADDING A MEMBER FROM GUATEMALA AND ONE FROM AN UNSPECIFIED EUROPEAN COUNTRY WOULD STRENGTHEN THE COMMISSION. WITHOUT MAKING SPECIFIC REFERENCE TO MRTA'S DEMAND THAT THE GOP RELEASE MRTA PRISONERS IN EXCHANGE FOR HOSTAGES, CERPA WROTE "WE CONSIDER THAT OUR ORGANIZATION'S FUNDAMENTAL REQUEST (PRISONER RELEASES) BE DISCUSSED."

THOSE INTERVIEWS, CERPA SAID HE BELIEVED JOSE MARIA ARGUETA, GUATEMALA'S AMBASSADOR TO PERU AND A FORMER HOSTAGE, WOULD BE A VALUABLE PRESENCE ON THE GUARANTOR COMMISSION. HE ALSO DENIED THAT MRTA IS SEEKING RANSOM MONEY FOR THE RELEASE OF THE JAPANESE AND JAPANESE-PERUVIAN BUSINESSMEN. THE MRTA LEADER SAID HIS COMMAND IS PREPARED FOR A LONG NEGOTIATION PROCESS, NOTING THAT HIS GROUP TRAINS FOR EXTENDED OPERATIONS, WHETHER "IN THE COUNTRYSIDE OR THE CITY." CERPA DID NOT SPECIFY WHO HE WANTED TO REPRESENT THE MRTA ON THE GUARANTOR COMMISSION. (U) PRESIDENT FUJIMORI CONVENED GOP INTERLOCUTOR DOMINGO PALERMO, PRIME MINISTER ALBERTO PANDOLFI, INTERIOR MINISTER GENERAL JUAN BRIONES, VICE FOREIGN MINISTER JORGE VOTO-BERNALES, AND INTERIM JAPANESE AMBASSADOR TERUSUKE TERADA ON THE AFTERNOON OF JANUARY 15 TO DISCUSS THE MRTA COUNTEROFFER. PALERMO RELEASED TO THE PRESS THE ESSENTIAL CONTENTS OF MRTA'S RESPONSE, NOTING THAT "FOR REASONS PERTAINING TO THE NEGOTIATING PROCESS, THIS PROCESS WILL CONTINUE WITH THE NECESSARY PRIVACY."

6. (U) PALERMO ANNOUNCED TO THE PRESS ON JANUARY 16 THAT THE GOP WOULD NOT ACCEPT MRTA'S IDEA OF ADDING A GUATEMALAN REPRESENTATIVE TO THE GUARANTOR COMMISSION, NOTING THAT THE SUGGESTION "IS INTENDED TO ESTABLISH AN ANALOGY WITH AN ENTIRELY DIFFERENT REALITY." PALERMO ALSO FORMALLY ANNOUNCED THAT THE GOP WOULD NOT PERMIT DIRECT VISITS TO MRTA PRISONERS "TO PREVENT A DISRUPTION OF THE DIALOGUE PROCESS." THE GOP HAD SUSPENDED ICRC VISITS TO PRISONS AND FAMILY VISITS TO MRTA PRISONERS AFTER MRTA STORMED THE JAPANESE AMBASSADOR'S RESIDENCE.

8. (U) ARCHBISHOP JUAN LUIS CIPRIANI TOLD REPORTERS THAT HE HAS THE CHURCH'S PERMISSION AND IS PREPARED TO PARTICIPATE AS A MEMBER OF THE GUARANTOR COMMISSION. PRESIDENT FUJIMORI'S FAVORITE CLERGYMAN ACCOMPANIED PRESIDENT FUJIMORI AND VISITING ECUADORIAN PRESIDENT BUCARAM ON A VISIT TO A VILLAGE IN CIPRIANI'S AYACUCHO DIOCESE ON JANUARY 14. OVER THE NEXT FEW DAYS, HOWEVER, WE ANTICIPATE THAT THE ARCHBISHOP WILL HAVE TO SHIFT HIS FOCUS FROM THE HOSTAGE CRISIS TO THE CHURCH'S LAYING TO REST OF PERU'S POPULAR RETIRED CARDINAL, JUAN LANDAZURI, WHO DIED OF CANCER ON JANUARY 16.

9. (U) THE ICRC ANNOUNCED PUBLICLY ON JANUARY 15 THAT IT IS PREPARED TO PARTICIPATE ON THE GUARANTOR COMMISSION AS AN INDEPENDENT AND IMPARTIAL ENTITY WITH A DIFFERENT ROLE THAN THE OTHER GUARANTORS. ICRC WILL "FACILITATE A DIALOGUE" AND PARTICIPATE DIRECTLY IN DISCUSSIONS RELATED TO "HUMANITARIAN ISSUES." IN HIS JANUARY 16 ANNOUNCEMENT, PALERMO ACCEPTED THE ICRC'S SELF-IMPOSED LIMITATIONS FOR ITS PARTICIPATION ON THE GUARANTOR COMMISSION.

15. (U) MRTA RELEASED ON JANUARY 17 POLICE COMANDANTE LUIS VALENCIA HIRANO, CHIEF OF THE ANTI-TERRORISM POLICE'S DELTA UNIT. ICRC CHIEF DELEGATE MICHEL MINNIG ANNOUNCED THAT VALENCIA WAS RELEASED FOR HEALTH REASONS. VALENCIA, WHO WALKED OUT OF THE JAPANESE AMBASSADOR'S RESIDENCE WITHOUT ASSISTANCE, WAS TAKEN TO A POLICE HOSPITAL. (U) A TEAM FROM THE NGO INTERNATIONAL RESCUE COMMITTEE WHICH INCLUDES AT LEAST FIVE AMERICAN AND THREE JAPANESE MEMBERS, ARRIVED IN LIMA ON JANUARY 14 TO OFFER THE GOP MEDICAL, NEGOTIATING, TRANSLATING, AND LOGISTICAL SUPPORT DURING THE HOSTAGE CRISIS. AMCIT MEMBER ARTHUR JOHNSON TOLD US THAT SOME OF HIS COLLEAGUES WERE PREPARED TO ACT AS "HUMAN SHIELDS" IF NECESSARY TO FACILITATE A NEGOTIATED TRANSFER OF THE MRTA HOSTAGE TAKERS TO A THIRD COUNTRY.
