

- 1. CLASSIFIED BY JIM WAGNER, POLITICAL COUNSELOR, EMBASSY LIMA. REASON: 1.5 (D).
- 2. SUMMARY: STATING PUBLICLY THAT HE WILL ONLY USE FORCE IF FACED WITH AN "UNCONTROLLABLE EMERGENCY" AT THE HOSTAGE SITE, PRESIDENT FUJIMORI CONTINUES TO STRESS THAT HE SEEKS A PEACEFUL SOLUTION TO HOSTAGE CRISIS. THE GUARANTORS CONTINUE TO MEET SEPARATELY WITH THE GOP AND THE MRTA TO HELP FRAME A POTENTIAL AGREEMENT, BUT THE MRTA'S INSISTENCE THAT THE GOP RELEASE MRTA TERRORISTS MAKES IT UNLIKELY THE GOP AND MRTA WILL COME TO ANY NEGOTIATED ACCORD ANYTIME SOON. END SUMMARY.




LIMA 03072 01 OF 03 092235Z PRESIDENT FUJIMORI REITERATES INTEREST IN PEACEFUL SOLUTION

IN A LIVE APRIL 6 TELEVISION INTERVIEW, PRESIDENT ALBERTO FUJIMORI REITERATED HIS COMMITMENT TO SEEK A PEACEFUL RESOLUTION TO THE HOSTAGE CRISIS. THE PERUVIAN PRESIDENT SAID HE ANTICIPATED THAT HE WOULD ONLY USE FORCE IF HE WERE "FACED WITH AN UNCONTROLLABLE EMERGENCY" INSIDE THE JAPANESE AMBASSADOR'S RESIDENCE. COMMENDING THE WORK OF THE GUARANTOR'S COMMISSION, FUJIMORI SAID THE GUARANTORS WERE HELPING "TO CREATE THE PROPER CONDITIONS" FOR A MEETING WITH MRTA LEADER NESTOR CERPA CARTOLINI AND GOP INTERLOCUTOR DOMINGO PALERMO. FUJIMORI ALSO USED THE INTERVIEW TO STRESS THAT "EACH AND EVERY ONE OF THE HOSTAGES IS IN OUR MIND."


4. (U) THE GUARANTORS CONTINUED TO MEET SEPARATELY WITH THE MRTA TERRORISTS AND GOP OFFICIALS. ARCHBISHOP JUAN LUIS CIPRIANI MET WITH PRESIDENT FUJIMORI FOR TWO HOURS ON APRIL 8; GOP INTERLOCUTOR PALERMO JOINED THEM MIDWAY THROUGH THE MEETING. CONFRONTATION WITH SECURITY FORCES.

REPORTED
THAT SOME HOSTAGES HAD BEEN DISCUSSING THE POSSIBILITY OF
CONFRONTING THE HOSTAGE TAKERS OVER THE WEEKEND, BUT HAD STOPPED
DOING SO NOW. HE SAID THE HOSTAGES WERE VERY AWARE OF THE FACT
THAT NO DIRECT GOP-MRTA TALKS HAD TAKEN PLACE SINCE MARCH 12, AND
INEVITABLY, SOME OF THEM WOULD AGAIN CONSIDER TAKING MATTERS IN
THEIR OWN HANDS. THE MRTA HOSTAGE TAKERS, HE SAID, REMAINED
UNITED AND DETERMINED. COMMENTING THAT ANOTHER GUARANTOR (READ
ARCHBISHOP CIPRIANI) HAD PROVIDED THE MRTA WITH A SOCCER BALL,
FRESH BATTERIES, AND NEWSPAPERS, HE SAID CERPA WAS NOT FEELING
UNDULY PRESSURED. THE SECURITY FORCES OUTSIDE THE RESIDENCE PLAY

(U) ON THE HEELS OF PRESIDENT FUJIMORI'S APRIL 4-5 VISIT TO BOLIVIA, GUARANTOR CANADIAN AMBASSADOR ANTHONY VINCENT TRAVELED TO LA PAZ APRIL 6-8, WHERE HE MET WITH BOLIVIAN PRESIDENT SANCHEZ DE LOZADA. VINCENT, WHO IS ALSO ACCREDITED AS CANADA'S AMBASSADOR TO BOLIVIA (RESIDENT IN LIMA), TOLD REPORTERS THAT HIS TRIP WAS PART OF HIS REGULAR, ROUTINE TRAVEL TO LA PAZ, AS WELL AS A CHANCE TO UPDATE THE GOVERNMENT OF BOLIVIA ON THE HOSTAGE STANDOFF. HE TOLD REPORTERS THAT BOLIVIAN AMBASSADOR JORGE GUMUCIO, THE ONLY HOSTAGE WHO IS NOT A CITIZEN OF PERU OR JAPAN, IS IN GOOD HEALTH.





10. (U) SOME 20 MEMBERS OF THE PRESS FOLLOWED ARCHBISHOP CIPRIANI'S CAR TO CALLAO NAVAL BASE THE EVENING OF APRIL 4. LIMA'S MEDIA OUTLETS SUBSEQUENTLY REPORTED THAT CIPRIANI VISITED MRTA LEADER VICTOR POLAY INCARCERATED AT THE NAVAL BASE'S SMALL MAXIMUM SECURITY PRISON. ONE PRO-GOVERNMENT LIMA DAILY EVEN REPORTED IN DETAIL A PURPORTED EXCHANGE CIPRIANI HAD WITH POLAY. PRESIDENT FUJIMORI, HOWEVER, CATEGORICALLY DENIED THAT CIPRIANI VISITED POLAY. IN THE AFOREMENTIONED TELEVISION NEWS INTERVIEW, FUJIMORI SAID CIPRIANI LOANED HIS CAR TO A FELLOW PRIEST WHO VISITED SOME FAMILY MEMBERS ON THE BASE.

11. COMMENT: IN THE ABSENCE OF ANY SIGNIFICANT DEVELOPMENTS IN THE PROTRACTED HOSTAGE STANDOFF, FALSE STORIES LIKE CIPRIANI'S CALL ON POLAY TAKE ON A LIFE OF THEIR OWN. CONGRESSMEN RAFAEL REY REY, A CLOSE FRIEND OF CIPRIANI, TOLD POLOFFS THAT EVEN AFTER HE CONFIRMED WITH THE ARCHBISHOP THAT NO SUCH VISIT TOOK PLACE, REY'S OWN FATHER REFUSED TO BELIEVE THAT CIPRIANI DID NOT MAKE THE TRIP TO CALLAO. CIPRIANI, WHO HAS UPBRAIDED THE PRESS ON SEVERAL OCCASIONS FOR INVENTING NEWS STORIES, APPEARS TO HAVE SUCCEEDED IN DIVERTING AND EMBARRASSING THE NEWS-STARVED PRESS. END COMMENT.





THE GUARANTOR SUB-GROUP WHICH VISITED FIVE MAXIMUM SECURITY PRISONS (BUT NOT THE PRISON AT CALLAO NAVAL BASE)

PRESENTED ITS REPORT TO THE GUARANTORS ON APRIL 8.

DIPLOMAT AND SUB-GROUP MEMBER TOLD POLOFF THAT THE REPORT MAKES "PALATABLE" RECOMMENDATIONS FOR IMPROVEMENTS IN PRISON CONDITIONS. EXPRESSED SOME HOPE THAT THE REPORT WOULD ALSO DISPEL THE MRTA HUSTAGE TAKERS' MISCONCEPTIONS OF THE CONDITIONS FACED BY THEIR COMRADES. THE MRTA TERRORISTS HAD ALLEGED THAT MRTA PRISONERS WERE BEING DENIED MUCH-NEEDED MEDICAL TREATMENT, BUT THE SUB-GROUP FOUND NO SUCH CASES.
