1. CONFIDENTIAL-ENTIRE TEXT.
2. DEPT. CAN PROVIDE A COMBINED TRAINING COURSE FOR 6 DOGS AND 6 "HANDLERS" FROM THE CIVIL GUARD AND 6 DOGS AND 6 "HANDLERS" FROM THE REPUBLICAN GUARD WITH THE COURSE TO BE HELD AT THE LOUISIANA STATE POLICE ACADEMY, BATON ROUGE, LOUISIANA FROM OCTOBER 20, 1986 - DECEMBER 19, 1986
3. SINCE GOP STATE SECURITY HAS NO DOG FACILITIES AT THE PRESENT TIME, IT IS NOT FEASIBLE FOR THAT AGENCY TO BE PROVIDED WITH BOMB DETECTION DOGS.
4. DEPT. CAN ALSO OFFER DOG "TRAINER" TRAINING TO 2 PERSONNEL FROM THE CIVIL GUARD AND 2 PERSONNEL FROM THE REPUBLICAN GUARD AT SAME LOCATION FOR SAME LENGTH OF TIME.

CONJUNCTION WITH HANDLERS AND ANOTHER SIX DOGS, WHICH WILL NOT BE TRAINED IN U.S., BUT WILL BE RETURNED WITH GOP TRAINERS FOR TRAINING IN PERU.

6. PERSONNEL SELECTED FOR BOMB DOG HANDLER TRAINING SHOULD BE EXPERIENCED POLICE PERSONNEL WHO HAVE FURTHER EXPERIENCE WITH DOGS AND/OR HAVE SHOWN APTITUDE AND DESIRE FOR WORKING WITH DOGS. ALL SELECTED PERSONNEL MUST BE IN THE OFFICIAL POSITIONS REFLECTING DUTIES ASSOCIATED WITH THIS TRAINING AND/OR MUST BE ASSIGNED TO SUCH POSITIONS, DOG HANDLING/DOG TRAINING, UPON RETURN TO PERU.

7. PERSONNEL REPORTING FOR TRAINING SHOULD BRING AT LEAST 4 SETS OF WORK CLOTHING AND 2 PAIRS OF WORK BOOTS. AT LEAST TWO SEMI-FORMAL SLACK AND SHIRT COMBINATIONS SHOULD BE BROUGHT FOR TRIPS INTO URBAN SHOPPING AREAS. SINCE LOUISIANA CAN BE WET AND COLD DURING LATE FALL, APPROPRIATE OUTER WEAR SHOULD BE AVAILABLE

8. ALL DOGS WILL BE RETURNED WITH PROPER IMMUNIZATION AND A LARGE SUPPLY OF VITAMINS AND MEDICINE. DEPT. NEEDS INFORMATION AS TO COMPOSITION OF DOG FEEDING FORMULA SO THAT SAME DIET CAN BE FED TO ANIMALS IN THE U.S. TO AVOID PROBLEMS UPON SHIPMENT TO PERU.

9. DEPT. WILL PAY ALL DOMESTIC TRANSPORTATION AND FURNISH ALL PER DIEM. HOWEVER, WE WOULD ASK EMBASSY TO WORK WITH GOP ON THEIR FUNDING TRANSPORTATION TO NEAREST U.S. PORT OF ENTRY.
