2. DEPARTMENT CONFIRMS OFFER OF BOMB DOG TRAINING COURSE AT THE LOUISIANA STATE POLICE ACADEMY, BATON ROUGE, LOUISIANA FROM OCTOBER 20 THRU DECEMBER 19, 1986. THE TRAINING WILL PROVIDE A COMBINED TRAINING COURSE FOR 12 HANDLERS AND 4 TRAINERS AND A TOTAL OF 12 DOGS. AN ADDITIONAL 6 DOGS WILL BE PURCHASED BUT NOT TRAINED IN THE U.S. THEY WILL BE RETURNED WITH THE GOP TRAINERS TO BE TRAINED IN PERU.

3. POST IS REQUESTED TO PROVIDE 200 U.S. DOLLARS TO EACH PARTICIPANT AS AN ADVANCE OF THEIR PER DIEM ENTITLEMENT. REMAINDER OF PER DIEM ENTITLEMENT WILL BE PAID TO INDIVIDUALS UPON ARRIVAL IN BATON ROUGE. CHARGE PER DIEM
